In 2005, Coplan + Crane opened for business in a small office on the corner of Lake and Marion in Oak Park.

"It was just me and Greg and one assistant," says **Ben Crane**.

Ben and **Greg Coplan** had first met over coffee a couple of years earlier, when they both came into the office very early while working at the same law firm. They would each go off to practice law on their own but stayed in touch and helped each other with cases.

While considering a job offer from another firm, Ben thought of an option he liked better. He called Greg and asked if he wanted to become partners.

"He said 'absolutely,' and we were off to the races," says Ben. One of our first clients was a woman who had suffered broken bones after tripping and falling on improperly maintained pavement in Schaumburg. Ben and Greg worked the case relentlessly and ultimately caught a defense witness in a lie. The case settled for \$650,000.

Hon. Clayton J. Crane (Ret.) became Of Counsel, and experienced attorney **Ted Jennings** came on board.

Things were going well. That changed in 2017.

Greg suffered a hemorrhagic stroke that left him partially paralyzed. He was facing a long and uncertain road to recovery. Everyone at the firm prayed for his health - and also wondered about the future.

The firm was in the middle of a big case Greg had worked on extensively. A woman had been killed when her car, stopped in traffic, was rear-ended by a freight truck. The trucking company was fighting the lawsuit aggressively and the case was headed toward trial.

There was a lot riding on this case. Our clients were counting on us to help them get justice. We had invested a lot of resources into it and now we were without Greg's drive, experience and sharp legal skills. We came together. We moved forward and gave it everything we had – and we won.

A jury awarded the woman's family \$15 million. It was a record verdict in Winnebago County. It was also a pivotal moment for Coplan + Crane.

"That verdict gave us confidence that we would be able to keep the firm going," says Ben.

Ben says Blake, Stephen and Erv all stepped up in Greg's absence - to work on this case and others and maintain the

firm's relationships in the legal community.

We've worked on other big cases in the past few years. Kevin Burke joined the firm after decades as a successful medical malpractice attorney. Experienced and talented support staff members have been hired.

"We have really developed our bench strength," says Ben. "Everybody is su-

per engaged and we have great cases to work on."

Now in 2020, there is a new challenge – a pandemic.

From the beginning, Ben and Greg focused on scanning documents and going paperless as much as possible. In 2019, we made significant upgrades to our remote access, utilizing cloud storage that allows the team to work and meet the needs of our clients in all their diverse geographical locations. This ongoing commitment to technology and flexibility in work schedules – helped us make a smooth transition to working from home. We stay connected with clients. Attorneys and staff meet online every morning. This helps us be goal oriented and focused on working together.

While the pandemic has put many things on hold, we still have 18 months of trials lined up. We have cases in northern Illinois, Iowa, California and Wisconsin. We're involved in mass tort cases in Florida and Minnesota.

Illinois courts are slowly progressing towards reopening, but the future remains uncertain. He does know the firm is ready for whatever comes next.

"I think our firm is as prepared as anybody to deal with this or whatever gets thrown our way," Ben says. "We're ready for takeoff."


